EDC staff has developed a 14 question survey, which Renquist will recommend to the EDC Joint Operations Board (EDCOB) be emailed. The number of businesses to survey has not yet been determined, but there are just over 600 businesses being considered at this time. Renquist informed the committee that the EDCOB has supported financially the cities of Spicer and New London in their participation in a University of Minnesota (U of M) BRE program. Schmoll will be attending the Atwater City Council meeting tonight to help set up an onsite visitation program. Schmoll reviewed with the committee the comparison between the U of M and Synchronist programs (see attached). Synchronist does not provide the training to interview businesses, but Renquist and Jean Spaulding are certified in that area. The Ag Committee will be discussing whether or not to do a survey of the ag industry. Schmoll reviewed with the committee a timeline for the survey process, including the email survey and on-site visit process (see attached). LAA is working on updating the business contacts and email addresses in Synchronist. EDC staff is in communication with the Willmar Lakes Area

Chamber of Commerce as to its Grow Minnesota! program. Through the Grow Minnesota! program, the WLACC averages approximately 30 visits each year. The information obtained through the Grow Minnesota! visits is tabulated and entered into the Minnesota Chamber's database for ultimate presentation to the state legislature. EDC staff, as government employees, are unable to go on Grow Minnesota! visits and cannot obtain the compiled data due to privacy concerns. Renquist is contacted by the WLACC if local issues arise during a business visit. Schmoll will be visiting Marshall and Hutchinson, which are doing BRE surveys, as to their process. The committee discussed the EDC's potential survey versus the Grow Minnesota! program and determined it will move forward with a separate business survey. EDC staff is prepared to move forward with the Synchronist program. Schmoll will be participating with New London and Spicer on their U of M survey.

2014 goals/projects. The committee reviewed the four 2013 goals and projects and the more extensive list of potential projects (see attached). Schmoll recommended visiting the county's communities be included in the first goal and Nelson recommended a budget be included in the goals. Renquist provided information on the EDC's efforts to promote the Willmar airport. The St. Cloud Regional Airport just started flights by Allegiant Air to Orlando and Phoenix and by United to Chicago O'Hare Airport.

There being no further business, the meeting was adjourned at 12:03 p.m.
